The Board of Directors has contracted with an independent vendor, The Ballot Box, to serve as the Inspector of Election for the purpose of preparation, receipt and tabulation of the ballots for this meeting. The voting power of the Association is 1354 separate interests. Each separate interest is permitted one (1) ballot. Ballots will be mailed to the membership at least 30 days prior to the meeting and election date.

Return ballots must be received in the envelopes provided by the inspector by mail, or other certified delivery to: The Ballot Box, 3315 E. Russell Rd Ste A4 #156, Las Vegas, NV 89120. The deadline for the receipt of mailed ballots is close of business on October 24, 2023.

Ballots may also be delivered to the locked ballot box located in the lobby of the BHA office 370 S. Doheny Drive, Suite D Beverly Hills, CA 90211 during the HOA office's regular business hours. The deadline for ballots to be hand-delivered to the HOA office is October 26, 2023, by 3:00 PM.

If you would like a receipt for your returned ballot, you are encouraged to mail the ballot with tracking through the United States Post office, or other certified delivery service (UPS, Fed-Ex, DHL, etc.). You may also request a confirmation of receipt of your ballot via email to info@ballotboxservices.com.

***While a physical location is allowed for the delivery of ballots on the day of the meeting between 2:00 pm and 3:00 pm, seating will be limited for those who wish to stay and watch the count. Members are encouraged to return ballots by mail. To participate in the meeting and observe the ballot counting, log on to the virtual platform.**
