The voting power of the Association is 1354 separate interests. Each separate interest is permitted one (1) ballot. Ballots will be mailed to the membership at least 30 days prior to the meeting and election date.

Returned ballots must be received in the envelopes provided by the inspector by mail, or certified delivery such as UPS or Fed-Ex: The Ballot Box, 3315 E. Russell Rd., Ste A4 PMB 156, Las Vegas, NV 89120. The deadline for the receipt of mailed ballots is no later than 12:00 PM (noon) on October 27, 2026. Ballots will also be accepted at the meeting location on October 29, 2026. Ballots may also be delivered to the locked ballot box located in the lobby of the BHA office, 370 S. Doheny Drive, Suite D, Beverly Hills, CA 90211, during the HOA office's regular business hours. The deadline for ballots hand-delivered to this location is October 29, 2026, by 3:30 pm. If you would like a receipt for your returned ballot, you are encouraged to mail the ballot with tracking through the United States Post office, or other certified delivery service (UPS, Fed-Ex, DHL, etc.). You may also request a confirmation of receipt of your ballot via email to [info@ballotboxservices.com](mailto:info@ballotboxservices.com). Members may verify the accuracy of their individual information on the voting list by contacting [beverlywoodhoa@gmail.com](mailto:beverlywoodhoa@gmail.com). Any request to update/change information on the voting list must be submitted in writing.
